Eligible Claimants:	<p>The Promotion is only open to individuals aged 18 years or older who are residents of Australia, excluding management and employees of the Promoter, its associated companies/subsidiaries, Participating Retailers, and agencies associated with this Promotion.</p> <p>Only applicable to JH Market Trade account holders.</p> <p>“Employees” means any directors, management, employees, concessionaires, consultants, officers and contractors or other such people who perform work under the control of another in exchange for payment.</p> <p>The Promoter is responsible for determining whether a person is an Eligible Claimant in its absolute discretion.</p>
How to Participate:	<p>To participate in the Promotion, an Eligible Claimant must:</p> <ul style="list-style-type: none"> a) during the Purchase Period, purchase* any product from JH Market online, in store or through an account manager b) Spend the minimum amount to be eligible <p>*“Purchase” means to make payment in full for a Participating Product during the Purchase Period.</p> <p>For clarity “Purchase” does not mean:</p> <ul style="list-style-type: none"> (a) lay-buys or pre-orders made before the commencement of the Purchase Period or receipt of product; (b) purchases via eBay or similar online third-party internet websites; (c) second hand products. <p>THEN</p> <p>If the claim is deemed valid (allow three (3) business days for Validation):</p> <ul style="list-style-type: none"> (a) The Eligible Claimant will be rewarded the correct amount of JH Reward Points based on the subtotal.

Participating Products:	Any product that is held by JH Market at any of their showrooms and/or warehouses across Australia only.
Validation & Notification:	<p>All claims submitted in the Promotion will be reviewed by a representative of The Promoter ("Validation").</p> <p>Claimants must allow three (3) business days for Validation to be completed.</p> <p>Reward points will be compounded weekly, meaning that eligible customers will receive points each week based on the number of points they have accrued over that period. Customers are also limited to a total amount of 125,000 points throughout the promotional period.</p> <p>Example:</p> <p>John spends \$1,000 on week 1 of the promotion period. Conditions:	<p>All purchases exclude GST & Shipping and will not be factored into the final amount of a purchase.</p> <p>Customers are limited to 1 AFL game per week (maximum of 2 Double Passes).</p>

GENERAL CONDITIONS:

1. Details above and the following clauses collectively form the terms and conditions of this Promotion ("Terms and Conditions").
2. Each claimant is responsible for ensuring his or her familiarity with these Terms and Conditions at the time of participation. Participation in this Promotion is deemed acceptance of these Terms and Conditions. The Promoter's decision not to enforce a specific restriction (whether communicated to a claimant or not) does not constitute a waiver of that restriction or of these Terms and Conditions generally.
3. The Promoter's decision in relation to any aspect of these Term and Conditions and the Promotion is final and binding on every person who participates. No correspondence will be entered into.

4. This Promotion is not valid in conjunction with any other offer.
5. Any values stated in these Terms and Conditions are in AUD/RRP/including GST.
6. The Promotion may be extended at the Promoter's absolute discretion.
7. Claimants can only participate in the Promotion in their own name. Claimants who enter using multiple aliases (e.g., multiple names, addresses and/or email addresses, trade account other than their own) will be disqualified.
8. Incomplete, indecipherable, or incorrect claims will be deemed invalid. Claimants are responsible for ensuring their correct personal details are provided and any updated details are notified to the Promoter. The Promoter accepts no responsibility should an Eligible Claimant fail to receive their JH Reward Points because of a failure to notify the Promoter of correct details or of a change to their details, or for providing invalid information.
9. Claims are deemed to be received at the time of receipt into the Promoter's database, not time of transmission by the claimant.
10. The Promoter is not responsible for any undelivered emails due to a claimant's spam filters or email settings.
11. The Promoter shall not be liable for any JH reward Points being lost, deleted, stolen, damaged or tampered with in any way before it reaches a claimant or after it has been released to a claimant.
12. The Promoter may, in its sole discretion, declare any claim or claimant invalid if the claimant:
 - a) disrupts, annoys, abuses, threatens, harasses, or attempts to do any of these things to the Promoter, another claimant or potential claimant of, or anyone else associated with, this Promotion.
 - b) Enters the promotion that is not in accordance with these Terms and Conditions or who tampers with the claim process; or
 - c) engages in conduct in relation to this Promotion, which is misleading, deceptive, fraudulent, or damaging to the Promoter's goodwill or reputation.
13. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law to modify, suspend, terminate, or cancel the Promotion, as appropriate, subject to any directions from any relevant authority.
14. The Promoter may communicate or advertise this Promotion via Facebook. However, the Promotion is in no way sponsored, endorsed, or administered by, or associated with, Facebook. Claimants are providing their information to the Promoter and not to Facebook. Each claimant completely releases Facebook from all liability.
15. Reward points are not transferable or exchangeable and cannot be taken as cash.
16. The:
 - (a) Promoter & the Promoter's related entities, and:
 - (b) the employees, agents, directors and contractors, of all entities referred to in this clause, shall not be liable for any loss or claim, action, demand, liability, damage, cost, expense or personal injury whatsoever (including but not limited to any direct, indirect or consequential loss), incurred, suffered or sustained by any person or entity (without limitation) in connection with, or arising from, the Promotion or acceptance of a Reward Points, except that which cannot be excluded by law (in which case that liability is limited to the maximum extent allowable by law).

17. Claimants must, at the Promoter's request, participate in any Promotion activity (such as publicity and photography) relating to participating in the Promotion, free of charge, and they consent to the Promoter using their name and image in any future promotional material.

18. PERSONAL INFORMATION

19. Immediately upon submission by a claimant, their claim becomes the sole property of the Promoter.

20. All information claimants provide ("Personal Information") will be used by the Promoter for the purpose of administering this Promotion and awarding JH Reward Points

21. The Promoter may disclose claimants' Personal Information to its contractors and agents to assist in conducting this Promotion and as required, to Australian regulatory authorities.
